The Gulf Cooperation Council (GCC) has established the Gulf Technical Regulation for Low Voltage Electrical Equipment and Appliances, enforced since July 1, 2016, to standardize safety, quality, and electromagnetic compatibility (EMC) requirements across member states . Key points include:

- Gulf Conformity Mark (G Mark): All LV equipment must bear this mark to demonstrate compliance.
- Product Categorization: Equipment is classified into List 1 (lower hazard) and List 2 (higher hazard). List 1 products require a Declaration of Conformity, while List 2 products require a Gulf-type examination by a Notified Body.
- Technical Documentation: Manufacturers must maintain documentation for risk assessment, design, and compliance verification.



- **Safety and EMC Requirements:** Equipment must meet essential safety standards to protect users, property, and the environment.

Saudi Arabia – SEC Specifications

The Saudi Electricity Company (SEC) provides detailed specifications for low-voltage complete sets, particularly for outdoor unit substations combining transformers and LV distribution panels . Key technical features include:

- **Voltage Ratings:** Distribution transformers up to 36 kV with 400/230 V LV output.
- **LV Panels:** Dual low-voltage panels with aluminum busbars, main circuit breakers, and outgoing MCCBs.

- **Pre-Approval Requirement:** Manufacturers must obtain LVSGC pre-approval for LV switchgear panels (MDB, MCC, SMDB, FDB), bus trunking systems, circuit breakers (ACB, MCCB, RCD, MCB), capacity banks, and automatic transfer switches.
- **IEC Standards Compliance:** All equipment must meet IEC standards for design, testing, and installation.
- **Approved Vendor List:** Only pre-approved products are allowed for use in customer premises and utility networks.
- **Guidelines:** LVSGC provides detailed design, testing, and installation guidelines to ensure safety, reliability, and operational efficiency.

Design and Construction Features
